Karina Lucas' engagements include *Pinocchio* (title role) and Third Lady (*Die Zauberflote*) for Opera North; Witch (*Macbeth*) for Scottish Opera; Dorabella (*Così fan tutte*), Leila (*Iolanthe*), Smedlerina (*Love for Three Oranges*), Kitchen Boy (*Rusalka*), Giovanna (Rigoletto) and Wowkle (*La Fanciulla del West*) at Grange Park Opera; Sara (*Tobias and the Angel*) at the Young Vic; Flora (*The Enchanted Pig*) at the Royal Opera House Covent Garden and the Victory Theater, Broadway; Dorabella (*Così fan tutte*) for the Ryedale Festival; Baba the Turk (*The Rake's Progress*), Pauline (*Pikovaya Dama*), Mother, Granny, Giant (*Into the Woods*) and Meg Page (*Falstaff*) for the Royal Northern College of Music; Annina (*La Traviata*) for Pimlico Opera; Sesto (*Giulio Cesare*) for the Yorke Trust; and Olga (*Eugene Onegin*) for Opera 74.

As a Park Lane Group Young Artist, Karina made her debut at the Purcell Room in January 2007, with duo partner Simon Lane, since when she has given recitals at: the Brighton Festival; the Leeds Lieder Festival; Ripon Cathedral; St. John's Smith Square; St. James Picadilly; the Oundle International Festival; Abbotsholme; the Oxford Lieder Spring Series and has been invited to perform at the Wigmore Hall. Karina and Simon released their first disc 'From the Old World to the New', in collaboration with violinist Rebecca Jones, on the Sonimage Label (2011).

Her commercial recordings include Sara (*Tobias and the Angel*), described by BBC Music Magazine as '*vivacious and vibrant*'.

In 2014, Karina Lucas sang the roles of Rosie Probert and Mrs Cherry Owen in the world premiere of John Metcalf's new opera Under Milk Wood. A commercial recording was released in November 2014.
